


New Outage Map Coming to SEC



Your Cooperative is in the process of rolling out a new Outage Management System (OMS) beginning mid-January! In addition to calling in outages Members will have the ability to report their outage online via the Cooperative website, www.se-coop.com.

The OMS will have several exciting features that Members will find very helpful. Once fully deployed, this outage system will not only give Members the ability to report an outage online, they will also be able to see updates on the power restoration progress. The map will be filtered by zip codes with the ability to zoom in to a 3 mile radius of an outage as well as see the number of outages in a given area. *Pictured above is an example map from a neighboring Cooperative.*

With OMS, it is vital that when a Member calls in to report an outage that they have their account number or meter number available. This will streamline the process and ensure location accuracy for the mapping system. It is also very important that the Cooperative has the most up to date phone number on file for your account. In the event of an emergency or a dangerous situation your Cooperative wants to be sure that we can contact you quickly.

"One of the biggest benefits of our new OMS will be the ability to give our Members a better estimated restoration time," said Dennis Cullum, SEC's Plant Accountant/Dispatch. "At a later date, Members will also be able to sign up for alerts that confirm outages as well as an alert sent when power has been restored to an area."

While this new system will make it much easier for Lineman to resolve issues and troubleshoot outages; the repairs, once the problem is found, will still have to be carried out in a safe and efficient manner. The OMS is in place to make locating outages and getting to the cause of the outage much faster.
